## **Mattoon Golf and Country Club Organization and Brief History**

The Mattoon Golf & Country Club was organized in 1920 by a business group in Mattoon. Fifty acres of land was leased east of Mattoon from J A McFall with an option to buy after a ten year period. L G Lockwood, a recognized golf architect at French Lick Springs, Indiana, was employed to lay out the nine hole golf course. A contract to build a club house was let to A C Loomis for \$23,600. The Club started with 200 members. Allen Wyman was the Golf Professional in the 20's; Jack Waddell, a Scotsman, in the 30's and 40's; Ardell Spaulding in the 50's and into the 70's; and Mark Lee from 1994 to 2013.

The Clubhouse has been remodeled several different times and the porches have been enclosed. Extensive renovation was completed in 1986. An additional nine holes of golf was added and opened for play in 1972. A swimming pool was built beside the Clubhouse in 1966 and tennis courts were added to the facility in 1986. The latest renovations to the Clubhouse were made in 2018 and 2019 and included a total renovation of the St. Andrew's Pub, the addition of a deck, remodeling & replacement of the clubs bathrooms, workstations and carpeting, and improvements / updates to ceilings and sound system.

# Membership Information

## Admission:

The application must be accompanied by the appropriate fees in force at the time of the application. Prospective new members will be issued a temporary membership number until their application is approved by the Board of Directors.

## Resignation:

As recommended by Walter sManagement Group & adopted by the Club's Board of Directors in January of 2015, the following amendments are in effect for stockholding members.

- Members may not move to a lower class unless the member is currently in the Platinum Class and moving to the Gold Class. Or any class to social.
  
- Gold Members may not move to a lower "golfing" class unless:
  - 1) That member remains at the social class for one (1) year, then returns to the Gold or Platinum Class.
  - 2) Resigns membership for one year, then returns to membership at the stockholding class; Platinum or Gold.
  - 3) A member who moves to the social class for less than one year and desires to move back to their original, or higher class, may do so by paying the back dues associated with the original class.

## Summary of Application Requirements:

It is agreed that this membership and all persons using the Club under this membership are bound by and shall comply with all By-Laws, Rules and Regulations of the Club as currently written or hereafter amended. I agree to pay all charges by the due date. Delinquent balances shall be subject to late fees and interest. If I fail to keep my account current, the Club may at any time declare the entire unpaid balance immediately due and payable. I authorize the Club to charge my credit card account for all amounts due and payable from time to time, and I shall provide updated credit card information upon request. I agree to pay all costs of collection, including contingency collection agency fees and in the event of suit, all attorney's fees up to 50 percent of the amount owed plus costs of suit. I authorize verification of the information provided on this form as to my credit and employment. I understand the minimum length of membership is one year, and no resignation thereafter shall be effective until received in writing by the club.

## Stock:

The stock certificate issued to a married couple may be in the name of either spouse or in the name of both spouses. Upon application for membership by a husband and wife (or request for change in certificate), stock shall be issued in joint tenancy in common, naming the spouses as owners. If the stock is issued in tenancy in common or joint tenancy to husband and wife, they may cast one vote at any meeting of the Club. If the share of stocks issued to a husband and wife in joint tenancy or tenancy in common, both the husband and wife shall be obligated for all charges or expenses incurred at the club by either husband or wife or other persons charging on the account of that membership stock.

- Gold Members receive ONE complimentary guest per month.
- Preferred Seating — Ballroom/South Porch @ all Club events (1st come/1st served)
- Tee times can be made up to 30 days in advance (Non-Gold—48 hours in advance) Standing Tee Times are accepted for Platinum and Gold members only.
- Only Platinum or Gold members are allowed private carts stored off-site
- Free pool use for children over 21 and all grandchildren.
- Platinum and Gold entitlements — Stockholding member, voting rights and opportunity to serve as Board of Director.

## **Rules & Regulations**

- Enjoyment of the Mattoon Golf & Country Club by members, immediate family and guests is best served by observation of the by-laws and Club rules. The following rules and regulations have been adopted by the Board of Directors. All infractions of the regulations are to be reported to the General Manager. Infractions to be presented to the Board of Directors for disciplinary action must be in writing, stating the infraction date and the name of the member or members involved. Only when these procedures have been followed will any appropriate action be taken by the Board of Directors. "Immediate Family" shall include a member's spouse or significant other and unmarried children age twenty-five (25) and under, who is a bona fide part of the member's household and is a full-time student. A member's immediate family shall be entitled to such use and privileges of the Club as may be fixed by the Board of Directors. The member shall be responsible for the payment of any indebtedness incurred by them.
- Any member found guilty by the Board of Directors of violating any Club rule or of conduct unbecoming a gentleman or lady or conduct detrimental to the best interest of the Club or a member of the Club, shall be subject to reprimand, suspension or expulsion by vote of the Board of Directors.
- Additional rules deemed necessary for the operation of the Club may, from time to time, be posted or printed in the newsletter. Printing in the newsletter will be considered sufficient notice for a new rule.

## **Dues**

- Dues are billed one month in advance or annually upon request.
- All dues and charges are payable on receipt of the Club statement.
- On a case-by-case basis, the Board may approve a deferment of membership dues for up to six (6) months with no privileges of the club during the deferment. This deferment should not be construed as a "snow bird" clause.

## **Billing**

- All charges are payable on receipt of the Club statement.
- Members must sign their name and write their account number on all charge tickets.
- Please review the tickets to be sure the correct number is applied.
- Charges may be paid by credit card, or cash.
- All purchases are subject to applicable sales tax and service charge.

- An service charge will be added to all food and bar purchase
- There will be a twenty-five (\$25) dollar charge for any returned checks for “non-Sufficient Funds”.

### **Minimum Spending Requirements**

- There is no minimum food and beverage requirement for any member of the Club.

### **Delinquent Policy**

- All charges not paid in full within twenty (20) days from the billing date of a statement (1st of each month) will be delinquent.
- A twenty-five (\$25) dollar service charge will be applied to an account that is delinquent and every thirty (30) days afterward an additional fifty (\$50) dollars will be charged until paid in full.
- Members whose accounts become 60 days delinquent will be contacted by letter. Accounts 90 days past due will be suspended. An account will only be reinstated once the members credit card is retained in their file.
- Any unpaid balance will be turned over to the Club’s collection agency and that member will be charged all additional collection fees.
- The Club staff is required to refuse service to any member who has been suspended from the Club.
- Sixty (60) days late automatically suspended from all Club privileges.
- Ninety (90) days late Board review for expulsion from the Club.
- A Certified letter will be mailed informing the member of his/her suspension or expulsion from the Club. An expelled member desiring reinstatement, within thirty (30) days after receipt of the expulsion letter, must apply for said reinstatement in writing, and monies covering the member’s total account must accompany application. The Board of Directors may or may not grant reinstatement

### **General Club Rules**

- In all cases, media attention involving the Club including newsprint, radio, or television, all news releases, requests for information, statements, or interviews will be under the direction of the General Manager who for this purpose is the official spokesperson for the Club.
- The General Manager shall have final authority over the performance of any services rendered by workers and volunteers on Club property for any purpose.
- Hunting, fishing or boating is not allowed in or adjacent to the ponds, woods or streams located on Club property.

- Members are responsible for the conduct of their children and guests.
- Member's guests are welcome to dine in any outlet of the Club.
- Single members may register a "significant other" to participate in Club privileges. No green fee will be charged to the registered guest. The member shall be responsible for all charges of the registered guest.
- Members and guests are prohibited from bringing alcoholic beverages onto Club property. Golf outings will be addressed on a case-by case basis.
- The bulletin board in the Clubhouse, locker rooms and Golf Shop are to be used only for information distributed by the Club. Any other literature, items of personal nature, items for sale, business cards, or solicitations may not be posted on a bulletin board or anywhere on Club property without Board approval.
- No articles or material shall be placed on Club property or improvements or alterations made to the Clubhouse or grounds without prior approval of the Board of Directors.
- No member or guest shall remove from the premises any property belonging to the Club.
- All accidents involving injury to persons or damage to property shall be immediately reported to the General Manager and or Board President.
- Any property of the Club damaged by a member or his/her guest shall be paid for by the member.
- Motor vehicles are limited to 5 mph speed limit in the Club driveway and parking lot.
- Parking on grass is prohibited except when parking lot is full.
- No animals or pets may be brought onto Clubhouse property unless used for handicapped purposes (registered service animals), or by management based on Board approval.
- No animals or pets may be left unattended in a vehicle for an extended period of time.
- Members and guests will not reprimand, harass or use obscene language towards the Club's employees. All complaints regarding employees shall be made to the General Manager or Board President.
- Members shall not request employees to leave their assigned duty area or leave the premises.
- Members may not solicit or allow a Club employee to work at a private party outside of the Club without approval of the General Manager.
- Annual financial reports are available to share holding members upon request and may be picked up at the Clubhouse office.

- As required by the State of Illinois, the Mattoon Golf & Country Club is a Smoke Free Facility.
- Guests must be in the company of a member unless arrangements have been made in advance with the General Manager for the guest to be unaccompanied.
- With the exception of some events, a portion of the club's dining venues will be available for member ala carte dining in the evenings. Any function booking that would require the total use of all dining facilities during a time or on a day that members would normally expect food service, must be approved by the Board of Directors.
- Proper attire and shoes are required at all times in the dining areas and the bar.
- Drinking glassware is not allowed to be taken outside the Clubhouse or to the pool.
- At Club social events, management may restrict the maximum number of seats per table.
- Appropriate attire required for dining venues. See "Golf Attire" section of this handbook, with the exception that denim jeans are allowed at all times in the Clubhouse.

We encourage Membership to take a complimentary Canopy Dining Menu. These can be found in the entry hall of the clubhouse.

## **MGCC Bucks**

Dine "in house" Wednesday's and Fridays after 4pm and receive 20% of your food (only) bill in "Mattoon Bucks", to be used for future dining. Mattoon Bucks may be utilized towards future food or beverage purchased at the pool, clubhouse or lounge. Mattoon Bucks may also be used for Canopy Dining.

Mattoon Bucks may not be accumulated through dining related to outings or special events. Credits will be issued to member accounts within one week of the accumulation date.

"Friday Family Nights" on the patio WILL accumulate MGCC Bucks.

### **Private Party Regulation**

- On any Club property, the Board President has the final authority over the performance and services, rendered by outside workers or volunteers including, but not limited to, all entertainments, florists, bakers, photographers and other outside services hired by a member or group for an event. The General Manager or Board President may reject any entertainment, visible objects or listening experience that he/she believes to be in poor taste, vulgar, inappropriate or offensive.
- Members may hold or sponsor private parties, golf outings, or functions for non-member individuals, companies or groups with the approval of the Board of Directors. The Board of Directors may deny a function if he/she deems it is not the best interest of the Club.
- Events also require a security deposit that will be determined by the size of the group and will be due at the time of booking said event.
- Members are required to complete and return to the Club office all necessary tax forms and information concerning parties held at the Club.
- All decorations for events may not be attached to walls or ceilings and must have the approval of the General Manager or designee.
- At Club social events, management may restrict the maximum number of seats per table.
- The member shall have the final responsibility for all disputed or undisputed charges from the event.
- The Head Chef, at his/her discretion, may or may not engage the available resources of the Club to cater outside of the Club property.

### **Bar Regulations**

- The General Manager, or designee will refuse service to any customer who is believed to be intoxicated.
- MGCC staff will require proof of age of any customer suspected to be a minor.
- The manager on duty will direct any customer, who in the opinion of management is intoxicated, abusive, insulting, and profane or represents a physical threat to others or the property to leave the Club property. The General Manager will present the Board of Directors a written detailed report and list of witness names of any customer asked to leave Club property.

### **Golf Function Dining**

- Proper attire and shoes are required at all times in the dining areas and bar. Shoes with spikes are not permitted on the main level of the Clubhouse.
- Children may use the West Porch dining room unaccompanied as long as they are in proper attire and their conduct is not disruptive.

### **Swimming Pool Information — Swim at Your Own Risk**

- During the season, the pool will open every day at 10 a.m. and close at dusk. The hours of operation are subject to change in response to adverse weather conditions, which may delay opening or advance closing of the pool.

### **Pool Fees**

- There are no pool fees for any MGCC member in good standing.

### **Pool Rules**

- All persons under 18 years of age are requested to enter the pool area through the north pool gate, not through the adult members men's and ladies' locker rooms.
- A local non-member resident may be an accompanied guest no more than six (6) times in one season.
- Members may, for an additional charge of \$20 / month allow a nanny or babysitter whose age is 18 years or older, to bring up to 2 children under the age of 16 to the pool. Food or beverage consumed in this situation must be placed on the Member's account with the Member responsible for all charges. The babysitter or nanny has no additional club privileges unless accompanied by the member.
- The Illinois Department of Public Health requires all persons under the age of 16 to be accompanied by an adult at all times when in the pool area.
- All children who are not toilet trained must wear a *Swim Diaper*.
- Children over the age of 5 years old are asked not to use the baby pool.
- Regardless of age, any person not able to swim the length of the pool is restricted to the shallow end of the pool.
- No person under the age of 18 years will be allowed to use the men's or ladies' golf locker rooms.
- Lockers are provided in the pool changing rooms on a daily basis at no charge.
- No more than one person is allowed on the diving board at one time.
- No outside food or drink is allowed inside the pool area except for baby supplies.
- No glassware or glass bottles are allowed inside the pool area.
- Children are not permitted to play in the grassy area next to the patio, except when chaperoned during a Club sponsored social event.
- A telephone is located in the pool area for emergency use only.

## **Tennis Information**

- The club will provide a junior tennis program.
- All members and their children are eligible to use courts.
- The Tennis Coordinator shall determine whether the courts are playable and that the players are properly attired.
- Playing time starts promptly on the hour and will be for a maximum of one (1) hour per court while people are waiting to play. Court changes made on the hour regardless of how long players may have had the court. Doubles players may reserve the court for two (2) hour time slots.
- All players must be properly attired — tennis shoes, shirts, shorts or dresses.
- An accompanied guest may play tennis up to 12 times per year.
- No observers are allowed inside the fence. This includes children.
- Absolutely no vehicles (roller blades, skateboards, bicycles, mini-bikes, motorcycles, golf carts, etc.) or animals are allowed inside the fence.
- No food or glass drinking containers are allowed inside the fence.
- Adults (18 and over) have priority use on all courts between 8 a.m. and 11 a.m. and after 4 p.m. on weekdays and at any time on weekends and holidays.
- Juniors (10 years and under) shall play between 11 a.m. and 4 p.m. on weekdays, unless invited to play by an adult.
- Special events, reserved permanent time and league play shall have preference.
- Lessons shall be scheduled by the Tennis Coordinator at non-prime court time.
- League play and special events will be scheduled by the Tennis Coordinator.
- All fees for group lessons and special events will be collected by charge to member's account.

## **Golf Course Rules**

- The golf course, Golf Shop and cart operations are under the supervision of the PGA Golf Professional and the Grounds Superintendent. The policies and rules concerning the Golf Shop, carts and rules of play are determined by the Golf committee and Golf Professional and approved by the Board of Directors. The golf course maintenance practices are determined by the Board of Directors..
- The Golf Professional or designee shall determine that rules of play and golf course regulations are adhered to by members and guests. The Golf Professional and Grounds Superintendent have authority to prohibit or discontinue play by any person who is not adhering to the established Club golf rules. USGA rules govern all play except where posted local rules and conditions specify otherwise.
- The Golf Professional or designee has the complete authority to prohibit or suspend play due to weather conditions and to have the course vacated by players.
- The Golf Course Superintendent or designee has authority to close the course to play or limit cart use. The Superintendent may also close individual holes that may be deemed unplayable. Signs will be posted on the 1st tee and 7th tee designating the holes closed. If the course is closed, there will be no play or practicing on any part of the golf course, the practice green or practice area. The Club will make every effort to communicate course conditions or status of cart use via Facebook, email or text message.
- Members and guests are responsible for the damage or injuries caused to other members or guests, golfers, golf cart, Club property, spectators, employees, property owners' houses, vehicles and passengers hit by golf balls.
- The Golf Shop will provide information concerning available tee times and use of the course. Tee times may be made no more than one (1) week in advance.
- Dates and times of golf outings and Club events are printed in the Club newsletter each month. On days of golfing events, the Golf Shop shall inform all golfers of the time the course or individual holes are available or must be vacated.
- All practice areas are under the supervision of the Club's Golf Professional. MGCC provides a practice tee, putting green and chipping area with bunker. Practice on the course is allowed at appropriate times as determined by the Head Golf Professional or designee. Golfers should remain aware of their surroundings and fellow members who are playing the course.
- Playing groups will be limited to a maximum of four (4) players unless given permission by the Golf Professional, or designee.

- Every attempt should be made to play rounds of 9 holes within two (2) hours and 18 holes within four (4) hours. The Golf Professional or his designee has the duty and authority to require any group to speed up or allow others to play through. A group of more than four (4) players shall allow any group of fewer players to play through.
- If a group loses the distance of one (1) clear hole, it shall be its duty to invite a faster group to play through. A single player has no standing on the course and shall give way to all others.
- All divots shall be replaced, ball marks on the greens repaired and bunkers raked as soon as the player reaches the green. Players will vacate the green and surrounding area immediately upon holing out.
- Please use the tee caddies for broken tees. Trash is to be placed in containers provided on the course.
- In all Club tournament matches, the match must be played within the allotted time period or one or both sides must forfeit.
- Early players who tee off before 7 a.m. must give the right-of-way to maintenance workers to ensure their safety.
- It is encouraged that all play begin on the 1st tee. Other requests may be granted by the golf shop.
- All players in the Men's Calcutta and Club Championship must be at least 18 years of age, out of high school and not participating in a college golf program.
- It is every member's obligation and duty to report any negative activity by anyone on the golf course or golfing by unauthorized people on the golf course to the Golf Professional or Grounds Superintendent.
- All members must sign in at the golf shop before beginning play.

### **Guests**

- A guest is any person who is not a member of Mattoon Golf & Country Club .
- A social member is considered a guest when using the golf course.
- A guest may not play on the golf course more than three (3) times in any season. Guests must be accompanied by a member having golf privileges. Social members do not need to be accompanied by a golfing member.
- All guests must be registered in the Golf Shop before teeing off.
- The sponsoring member must play in the same group with the guest unless granted special permission by the Golf Professional or designee.
- Sponsoring members are responsible for the conduct, indebtedness of or infraction of any Club rules committed by their guests.



### **Golf Dress Code**

- Proper golf attire including shirts and shoes must be worn at all times on the golf course, practice green and driving range. The following garments are not proper golf attire and are specifically prohibited:

**Halter Tops**

**Short shorts, gym or jogging shorts**

**Metal Spikes**

**Tee Shirts and denim are discouraged.**

**Tank Tops**

**Bathing Suits**

- The Golf Professional and Golf Shop assistants **must** prohibit play by any member or guest who is not properly attired.

### **Golf Shop Hours (weather permitting)**

The Golf Shop will be open on a daily basis from March 1 to November 30.

Weekdays — 7:30 a.m. to 7:00 p.m. or later depending on course activity

Weekends — 6:30 a.m. to 7:00 p.m. or later depending on course activity

- Hours of operation may vary due to weather.. The golf shop staff will make every effort to communicate changes via email, Face Book or text message.
- Purchases of Golf Shop merchandise may be made by member account charge, credit card or cash.
- The practice tee is open March 1 through November 1, weather permitting. Only practice balls provided by the Golf Shop are allowed to be hit. .
- Carts are not allowed on the practice tee.
- Balls may be hit only from the designated tee settings.

### **General Cart Use**

All electric carts, Club or private shall operate during normal conditions under the 90 degree rule. That is, carts will enter the fairway at 90 degrees from the cart path. After a shot is played, the cart must return to the cart path at 90 degrees. If course conditions occur in which the Golf Course Superintendent feels cart use will cause turf stress or damage, the cart use may change and will be communicated by the golf shop staff.

### **Club Rented Carts**

- Hand carts and electric carts are available through the Golf Shop.
- Dependent on conditions, electric carts will be allowed twelve months of the year at the discretion of the General Manager.

- A person must be 16 years of age and possess a valid drivers license to operate a club cart, or private cart on club property.
- No more than two (2) players and their equipment shall be allowed on a cart for any round of golf.
- Carts may not be driven within **30 feet** of a green or past any white line except where cart paths are provided.
- Any damage to a Club owned golf cart by a member, a person of the member's family or their guest shall be financial responsibility of the Club member.
- **The Club encourages the use of one (1) Club owned cart per twosome and two (2) Club owned carts per foursome allowed. This policy will be strictly enforced.**

### **Private Cart Policy**

- Private golf carts allowed on the course are those owned and operated by Class A Stockholding members only.
- **All privately owned golf carts can be used by the members and their family who reside in that household and have a valid driver's license.**
- All carts must be electric and in good mechanical condition. Cart owners are responsible for meeting the State of Illinois requirements in regard to using golf carts on public roads. Carts must be driven to Club property. No trailers allowed.
- All private golf carts must be registered with the Club office annually, covered by liability insurance filed with the Club each year before the golf cart is to be used on the golf course. Each liability policy will name Mattoon Golf & Country Club as additionally insured. Once proof of insurance has been established, and annual trail fee (if applicable), and annual sticker will be issued to the golf cart owner which must be displayed on the golf cart in a visible area.
- No private carts may be left overnight on Club property without permission from the golf shop staff.
- Any requests for repairs or maintenance to privately owned carts should be directed to the Golf Course Superintendent. The rate of labor for these repairs and maintenance services shall be determined by the Golf Course Superintendent. A minimum of 1/2 hour will be billed to the member's account.

### **Additional Rules and Privileges**

Grandchildren of members, who participate in the Junior Golf program are allowed to play unlimited times with their sponsoring grandparent as long as the \$50 "grandchild" fee has been paid. The grandchild is not allowed to play golf without the sponsoring grandparent.

### **Golfing Rules Governing Times of Play**

Children up to age 13 shall play or practice **only when accompanied by an adult member** then only at the following times at the discretion of the Golf Professional or designee.

Holidays	After 1 p.m.
Sundays	After 2 p.m.
Mondays	Anytime
Tuesday	Before 2 p.m.
Wednesdays	Between 1 p.m. & 4 p.m.
Thursdays	Before 4 p.m.
Fridays	Anytime
Saturdays	After 2 p.m.

**Golfers age sixteen and over, play according to the adult time schedules.**

Non-League Participants Only restricted on Tuesday Men's Day. Non-league players must tee off prior to 11a.m. unless given permission by the Golf Professional

Men: Only restricted on Wednesday Ladies' Day. Men may not tee off prior to 11 a.m. unless given permission by the Golf Professional.

Note: An adult member is defined as a dues paying member, not just a 16 year old person.

**The Golf Professional has the authority to open the golf course during "*restricted times of play*".**

## **A Note Regarding MGCC Dress Code**

Having a specific dress code that covers the Club's wide range of events is difficult, if not impossible. Therefore, I ask that Members and guests dress appropriately for the occasion and the location at the club.

Bathing suits, other pool wear, gym clothes or other apparel deemed inappropriate by the Board of Directors is unsuitable for dining in our clubhouse or lounge. Appropriate looking denim is allowed in the clubhouse but discouraged on the golf course.

I recognize that the world today is more casual than ever before. At the same time, I request a respect for the traditions that help create an environment we all appreciate and which are conducive for the successful continued growth of the Club's membership.

# Mattoon Golf and Country Club By-Laws

Article I. The annual meeting of the Shareholders of the Mattoon Golf & Country Club shall be held on the last Tuesday in the month of November of each year at the Clubhouse in the County of Coles and State of Illinois. Written or printed notice, stating the place, day and hour of said meeting shall be delivered no less than ten (10) nor more than forty (40) days before the date of the Meeting, either personally or by mail, from the Secretary, to each Shareholder of record entitled to vote at said meeting, at his, hers, or its address, as it appears on the records of the Corporations.  
(Amended November 18, 1986)

## **SPECIAL SHAREHOLDERS' MEETING:**

Article II. Special Meetings of the Shareholders may be called by the President, by the Board of Directors or by the holders of not less than one-tenth (1/10th) of all the outstanding shares of the Corporation, upon giving at least ten (10) days notice to each Shareholder of record entitled to vote at such meeting, which notice shall state the place, day and hour of such meeting, and the purpose for which meeting is called. The person or persons desiring and calling said meeting shall sign a call for the same and, in case of Shareholders calling said meeting, the number of shares held by each shall be stated in said call. The said call shall be filed with the Secretary of the Corporation, and the Secretary shall then mail a notice of said meeting to each Shareholder at his, hers or its address, as it appears on the records of the Corporation and the Secretary shall also enter call upon the records of the Corporation and shall enter the fact of the mailing of such notice on said records, which entry shall be prima facie evidence of said mailing.

## **QUORUM AT THE SHAREHOLDERS' MEETING:**

Article III. The Shareholders necessary to constitute a quorum at any meeting shall not be less than the holders of a majority of the full amount of the capital stock issued by the Corporation.

## **MANNER OF VOTING:**

Article IV. At all meetings of Shareholders, each Shareholder shall have the right to vote in person or by proxy for the share owned by him or her for as many persons as there are Directors to be elected. On all other propositions to be voted upon by the Shareholders, each Shareholder shall have the right to vote in person or by proxy the share owned by him.  
(Amended August 26, 1986)

Article V. At the Annual Meeting of Shareholders, there shall be chosen by the Shareholders by ballot six (6) Directors, who shall exercise the corporation powers of the Corporation. The said Directors shall be elected for the term of one (1) year or until the successor are elected at the Annual Meeting of the said Shareholders, and have qualified as such Directors. The number of Directors shall not be increased or diminished or their term of office changed without consent of the owners of the majority of the shares of stock. Any vacancy occurring in the Board of Directors and any directorship to be filled by election at an Annual Meeting or at a Special Meeting of Shareholders call for that purpose and any vacancy arising between meetings of Shareholders by reason of an increase in the number of Directors or otherwise, by action of the Board of Directors. A Director elected by the Shareholders to fill a vacancy shall hold office for the balance of the term for which he or she was elected. A Director appointed to fill a vacancy shall serve until the next meeting of Shareholders at which are to be elected.

### **DIRECTORS' MEETINGS:**

Article VI. There shall be an Annual Meeting of the Directors immediately following the annual Shareholders' meeting, for the transaction of such business as may properly be brought before said Directors. There shall be a regular monthly meeting of the Directors. At all meetings, the majority of the Directors shall constitute a quorum. The time of day of said meetings shall be determined by the Directors, said meetings shall be held at the Clubhouse of the organization. Special Meetings of the Directors may be called by a Director giving a written or verbal notice of his intention to call such meeting to the other Directors at least twenty-four (24) hours before said meeting, such notice to set forth the time, place and business to be discussed at said meeting. Said Special Meetings shall also be held at the Clubhouse at Mattoon, County of Coles and State of Illinois, designated in said notice.

### **ADJOURNED MEETINGS:**

Article VII. All meetings of either the Shareholders or the Directors may be adjourned from time to time at the pleasure of said Shareholders or Directors respectively, for the purpose of considering or acting upon any unfinished business, but no business shall be transacted at an adjourned meeting which would not have been in order at the meeting originally called.

### **OFFICERS:**

Article VIII. The officers of the Corporation shall be the President, Vice President and Secretary-Treasurer. Said officers shall be elected at the Annual Meeting of Directors, to be held the last Tuesday in November following the Annual Shareholders' Meeting.

They shall hold their respective offices for the term of one (1) year, or until their successor are duly elected and have qualified, unless any or either of them are sooner removed because of disability or reasonable cause, upon due notice. Any officer of said Corporation may be removed at any time on account of disability or reasonable cause by the Board of Directors at a Special Meeting of the Directors called for such purpose by the affirmative vote of not less than a majority of such Directors

After notice being given to the person to be removed, at any meeting of the Board of Directors such a vacancy in said office shall be filled at once for the remainder of the term by the Board of Directors. All officers, as well as the Committees for the corporation, not otherwise provided for, shall be appointed and will be discharged by the Board of Directors.

### **PRESIDENT:**

Article IX. The President shall preside at the meetings of Shareholders and the Board of Directors. He shall, with the Secretary-Treasurer, sign certificates of stock, issued by the Corporation, and shall execute, with the Secretary-Treasurer, all deeds, leases, bills of sale, written contracts and other documents to be executed by the Corporation, unless otherwise provided for by the By-Laws or Resolution. He shall have general supervision of the business of the Corporation under the direction and control of the Board of Directors.

### **VICE PRESIDENT:**

Article X. The Vice-President shall preside at all meetings of the Shareholders and the Board of Directors in the absence of the President, and in the case of the absence or illness of the President, shall carry on the duties of the President so far as practicable.

### **SECRETARY-TREASURER:**

Article XI. The Secretary-Treasurer shall have charge of the Corporate Seal of the Corporation, and shall keep accurate minutes of the meetings of the Shareholders and the Board of Directors, shall issue notices of meetings, and shall have the custody of all papers and documents owned by the Corporation or under his charge, which are not otherwise provided for, and shall keep the same in the offices of the Corporation. He shall sign all Certificates of Stock and shall execute, with the President, all deeds, leases, bills of sale, written contracts and other documents to be executed by the Corporation, unless otherwise provided for by By-Laws or Resolution. He shall, under the supervision of and with the assistance of the President, look after and keep the accounts and records of the business of the Corporation and any Shareholder or his duly authorized and designated representatives shall have the right during regular business hours to make examinations and audits of said books of account and record of the Corporation, at the expense of said Shareholders.



## **BOARD OF DIRECTORS:**

Article XII. The Board of Directors shall have charge of the general affairs, funds and property of the Corporation. It shall be their duty to carry out the objects and purposes of the corporation, subject to its rules, regulations and By-Laws, and such other actions as the Corporation may take time to time. They shall determine the form of the Certificate of Stock and transfer there of, and declare all dividends. They may do all other things which the Director of like Corporations are legally authorized to do for the purpose of carrying into effect the objects of the Corporation.

## **FISCAL YEAR:**

Article XIII. The fiscal year of the Corporation shall begin on the first (1st) day of November of each year and end on the thirty-first (31st) day of October in each year.

## **SEAL OF THE CORPORATION:**

Article XIV. The seal of the Corporation shall consist of the regular circular seal with the following words printed in the center, "Corporate Seal", and with the following words, "Mattoon Golf & Country Club" around the same.

## **REGISTERED OFFICE AND REGISTERED AGENT:**

Article XV. The Board of Directors shall designate from time to time, a registered agent of the Corporation and a registered office for the Corporation, and such registered agent shall have an office identical with the registered office of the Corporation.

## **WAIVER OF NOTICE:**

Article XVI. Any Shareholder, Director or officer may in writing waive the giving or mailing of any notice required to be given or mailed either by or under the statutes of the State of Illinois or by or under these By-Laws.

Article XVII. The By-Laws of the Corporation may be altered or amended at any regular or special meeting of the Board of Directors, by the affirmative vote of a majority of all members of the Board of Directors.

Article XVIII. The Mattoon Golf & Country Club shall defend, save and hold harmless its officers from all claims and demands for damages, for any and all acts or omissions of its officers and Directors in the performance of their duties as officers and Directors of the Corporation. This duty to defend, save and hold harmless shall not apply to willful, contumacious or criminal acts. (Adopted February 18, 1991)

Article XIX. The Board of Directors, for good cause, and in its discretion may:

1. Censure a member in writing;
2. Suspend a member from one, a combination or all of the privileges of the Clubhouse, Golf Course, Tennis Courts and/or Pool; or
3. Expel a member from the Corporation

Violation of the By-Laws or rules and regulations of the Corporation by a member or a guest of a member shall constitute good cause. (The term "guest" shall include, but not be limited to, the member's spouse and descendants who do not own stock in the Corporation.) any act or conduct of a member or guest of a member which shall be found, by vote of the majority of the Board of Directors at a board meeting, to have been unbecoming a gentleman or a lady or to have been incompatible with the welfare, character or interest of the Corporation shall also constitute good cause.

The Board of Directors shall give the member ten (10) days written notice of a regular or special meeting of the Board of Directors at which meeting the Board will consider and determine whether that member shall be censured, suspended or expelled.

The notice shall:

1. Specify the date, time and place of the meeting to consider censure, suspension or expulsion;
2. Specify the provisions of the By-Laws or rules and regulations alleged to have been violated or the conduct, constituting good cause as defined herein; and
3. Be hand delivered or mailed to the member by Certified Mail, Return Receipt Requested, at his or her billing address as it appears on records of the Corporation.

The member may appear at the board meeting and present evidence and make such arguments as the member may deem necessary in defense.

The censure or suspension of a member shall require the affirmative vote of a majority of the Directors present at the board meeting, The expulsion of a member from the Corporation shall require the affirmative vote of not less than two-thirds (2/3) of the members present at a board meeting

The decision of the Board of Directors as expressed in any order or resolution of censure, suspension or expulsion, shall be un-appealable and binding on the affected member.  
(Adopted August 19, 1992)

**REAL ESTATE:**

Article XX. The Corporation may not sell improved real estate. The Corporation may sell, convey, transfer or otherwise dispose of unimproved real estate for cash consideration equal to the fair cash market value of the real estate, computed for the property's highest and best use, subject to an affirmative vote of not less than seventy percent (70%) of the issued and outstanding shares of the Corporation at a Special or Annual Meeting of the Shareholders. (Adopted November 16, 1994)
